**ORDER OF THE NASSAU COUNTY BOARD OF COUNTY COMMISSIONERS
FORGIVING CODE ENFORCEMENT LIEN AMOUNT**

Re: Violation of Ordinance 2003-17, Section 6.01 and Section 6.03 and Ordinance 97-19, Section 28.02 of the Nassau County Code of Ordinances.

This matter came before the Nassau County Board of County Commissioners for hearing in accordance with Section 162.07, Florida Statutes, on the 10th day of February, 2025, and based upon the evidence and testimony presented, the following Findings of Fact, Conclusions of Law and Order are hereby entered:

FINDINGS OF FACT

1. The property was found to be in violation of 2003-17, Section 6.01 and Section 6.03 and Ordinance 97-19, Section 28.02 of the Nassau County Code of Ordinances.
2. The fine amount ran from June 14, 2005, up to and including July 12, 2005, for a total of 29 days, at \$50.00 per day for a total fine amount of \$1,450.00. Administrative costs were assessed in the amount of \$354.58, for a total lien amount of \$1,804.58.
3. Due to a miscalculation, staff requested and received payment for only the administrative costs in the amount of \$354.58 and at this time, Staff requests that the Board forgive the outstanding lien amount of \$1,450.00.

CONCLUSIONS OF LAW

The testimony and evidence offered constituted competent substantial evidence as to good cause to support the forgiveness of the previously assessed lien of \$1,450.00.

ORDER

IT IS HEREBY ORDERED:

- (1) That the Respondent's lien amount of \$1,450.00 is forgiven. The Respondent previously paid the administrative costs in the amount \$354.58.
- (2) That pursuant to this Order and Section 162.09(3), Florida Statutes, the County Attorney shall prepare and record a Satisfaction and Release of Lien in the above-referenced case number.
