Policies WAT.01.01 & CI.02.01(D)

- These policies currently only include Level of Service (LOS) standards for Nassau Amelia Utilities (NAU) and Jacksonville Electric Authority (JEA), but not for the City of Fernandina Beach (COFB), nor for the new First Coast Regional Utilities (FCRU).
- This amendment proposes including LOS standards consistent for the two entities based on the City of Fernandina Beach Comprehensive Plan (which uses 350 g/d/ERU) and for FCRU's consumptive use permit (CUP) which establishes 85 gpd per capita per day.

Policy WAT.06.03

- This policy amendment is proposed to provide a corrected planning horizon consistent with the draft Water Supply Facilities Work Plan.
- The prior plan included a time horizon of 2019-2030 while the proposed plan includes a time horizon of 2025-2040.
- This amendment also proposes to remove the prior entity who assisted in the preparation of the previous Water Supply Facilities Work Plan.
